MWI Welding Competition Rules and Regulations 2024

- 1. Competitors shall conduct themselves as professionals at all times, foul language is not permitted.
- 2. Competitors are not allowed to have or possess cell phones or other electronic devices in the welding shop during their portion of the competition.
- 3. Competitors are not allowed to enter another competitor's booth once the competition has started.
- 4. Competitors may not speak to other competitors while working on their specified welding project.
- Competitors shall weld out coupons in specified welding positions using the proper electrode and electrode diameter.
- 6. Competitors failing to follow blueprint and fit-up instructions while assembling and welding their project will be disqualified.
- 7. Competitors shall not start work on their specified welding project until directed to do so.
- 8. Competitors shall weld all passes the full length of their coupons. DO NOT stagger your welding passes.
- 9. 90-minute time limit for High School division.
- 10. 90-minute time limit for Vo-Tech division.
- 11. In the event there is a tie the winner will be determined by the shortest project completion time. In the event there is a tie in completion time there will be a "Weld Off" to determine the winner.
- 12. All material and the welding procedure will be located in the booth.
- 13. Procedures, material and recommended machine settings will await each competitor inside of their booth.
- 14. Competitors must wear eye protection (safety glasses) at all times. NO EXCEPTIONS.
- 15. Once a competitor has completed their welding project(s) and turned it in to their section supervisor, they are to clean their work area and remain in their booth until dismissed.
- 16. Upon completion of the welding competition all welding coupons shall be the property of Missouri Welding Institute.
